

Beaten to the Line 2012

An analysis of whip offences in British racing

In the 12 months of 2012, under whip regulations introduced by the British Horseracing Authority (BHA) in October 2011, there was a decrease in the number of breaches compared with 2011. A total of 637 infringements were recorded (897 in 2011 and 887 in 2010).

Whip offences, therefore, fell by 29 per cent in 2012 compared with the previous year. However, as set out below, racecourse stewards have greater discretionary powers, which allow them to discount much off what previously would have been recorded as an offence.

Under the rules introduced in 2011, the number of times that a jockey may hit a horse in a race was halved to eight for a jump race and seven for a flat race. However, on 6 March 2012, amended whip regulations were implemented, under which stewards can use their discretion as to whether to punish a jockey for 'excessive whipping' (re branded by the BHA as the harmless sounding offence of 'Used whip above permitted level'). Potentially, this means that many more offences have gone unpunished.

Jockeys' offences

In 2012, 316 jockeys committed offences, with 152 offending on more than one occasion. In 2011, 356 breached the rules, with 196 offending multiple times. Despite the reduction, 316 individuals breaking the rules is hardly cause for celebration.

The highest total number of offences committed by a single jockey fell from 17 in 2010 to 13 in 2011, and to nine in 2012. While this can be seen as encouraging, it is still the case that a significant number of jockeys continue to repeatedly break the rules. The jockeys with the greatest number of offences (nine each) were Darren (DE) Egan and Adam Kirby. Some of the worst offenders in 2012 also featured at the top of offenders' lists in 2011 – i.e. Kieren Fox, Adam Kirby, Sean Levey, David Probert, Dale Swift and Robert Winston.

Penalties

Three jockeys were fined in 2012 and ten committed multiple offences, thus incurring a harsher accrued penalty. They were David Allen, Darren Egan, Kieren Fox, Jason Hart, Adam Kirby, Sean Levey, Barry McHugh, Ryan Powell, David Probert and Robert Winston.

The maximum number of days' penalty handed out to jockeys has risen significantly – from 52 days in 2011 for Mr RJ Cooper to 121 days for Kieren Fox in 2012.

Horses abused

Twenty-five horses were the victims of excessive whipping on more than one occasion in 2012 (compared with 49 in 2011). One of the equine victims, Flow Chart, was abused three times in the year by the same jockey – Robbie Fitzpatrick. Eight of the 25 horses were abused by the same jockey on each occasion.

Two horses who appear on the 2012 list are now dead. Four-year-old Juarla, and seven-year-old Imperial Guest.

Two horses – Fly Direct (IRE) and Gansey (IRE) – were wealed by the whip in 2012. In 2011, 11 were wealed.

Changes to the whip rules

A long-awaited review of the whip was published by the BHA on 27 September 2011, with the new rules applying from 10 October. The review document contained the following admission: 'The current whip guidelines and penalties for those jockeys who breach the Rules on whip use are not an effective enough control and deterrent in their current form.' Animal Aid's research showed that the BHA's old rules were being regularly and repeatedly flouted, with 887 breaches

during 2010, and 15 jockeys each committing ten or more offences. In the first six months of 2011, prior to the rule changes, there were more than 450 breaches, and ten horses were wealed by the BHA's so-called welfare-friendly cushioned whip. The new rules halved the number of times jockeys could strike their horses (eight times in a jump race and seven times in flat racing), limited the number of times a horse could be struck in the last part of the race and introduced financial penalties (loss of riding fees and prize money) for breaches. The minimum penalty of a 'Caution' was replaced by suspension days.

Just one month later, on 11 November, and following two bouts of rebellion and threats of strikes from jockeys over the new rules, the BHA predictably caved in and amended the rules to allow jockeys greater licence to hit horses. Under the amended regime, jockeys would keep their riding fees for breaking the rules, and would not incur a financial penalty unless they hit their horse three times more than the permitted number of strikes. The revised scheme also abolished the last furlong/last jump rule, which meant that jockeys could hit their horses more often in the last part of the race than previously allowed. The situation for trainers and owners of horses subjected to abuse remained the same — they keep their prize money and face no sanction whatsoever.





More concessions

On 21 February 2012 came even more radical concessions to jockeys. The former restrictions on whip strikes became merely a guideline – leaving horses who are repeatedly hit vulnerable to the subjective judgement of the Stewards as to whether or not they have been abused. The punishment regime has also been greatly weakened with the abandonment of the system of escalating penalties for each new offence. Under the new rules, previous offences are discounted when deciding on punishment for any fresh offence. Serious repeat offenders have always been referred to the BHA's Disciplinary Panel from which more serious sanctions can usually be expected. However, because the trigger point related to the number of days' suspension from racing has been raised, jockeys can accumulate more penalty days before having to answer to a special panel.

Of all these changes, perhaps the post pernicious and damaging to horse welfare is the discretion given to racecourse stewards to refrain from handing out a sanction to a jockey even though he or she may have clearly breached the rules. The punishment regime was also greatly weakened with the abandonment of the system of escalating penalties for each offence. Together, these changes will allow jockeys an almost free rein to beat their mounts into submission.

Whip advocates often claim that horses do not feel the whip because of the adrenalin provoked by the race. But as a racing correspondent for *The Guardian* noted in a 2010 article, 'If the horse didn't feel it, there would be no point in using it. In any case, the lasting pain caused by overuse may certainly be felt after the event.' He went on to add: 'A sound whipping is a poor reward for any horse that has given its all.'

Even if there is less use of the whip, any use of it is wrong. Jockeys whip horses in order to bully and intimidate them into running up to and beyond their physical limits. The public knows this, which is why, according to a poll commissioned by the British Horseracing Authority itself, 57 per cent of people want an outright ban on the whip.
